



# SHOW SANCTIONING AGREEMENT

It is understood and agreed that the term Sanctionor will, throughout the conditions of this agreement, refer to the duly appointed representative of the Southern Arizona International Livestock Association (SAILA) of Arizona.

1) **Sanctioned Show:** Sanctionor grants to Sanctionee permission to use the name of the Southern Arizona International Livestock Association (SAILA) as approving the Sanctionee's livestock show to be held in \_\_\_\_\_, Arizona on \_\_\_\_\_, 20\_\_\_\_\_, and the show will be called \_\_\_\_\_.

2) **Purpose:** Sanctionor agrees to compile the results of Sanctionee's 20\_\_\_\_\_ approved show as part of the SAILA youth member point totals in the official SAILA point standings.

3) **Fee Terms:** Sanctionee agrees to pay Sanctionor a pre-determined sanctioning fee of \$5.00 per exhibitor for the 20\_\_\_\_\_ approved beef, lamb, pig, and/or goat show(s). This sanctioning fee is due and payable within 14 days following the approved show date.

4) **Results:** Sanctionee agrees to submit the results of said show or contest in its entirety to SAILA via email or regular mail within FOURTEEN (14) days of the completion of said show or contest.

5) **Liability:** Sanctionee agrees to save and hold harmless the Southern Arizona International Livestock Association of Arizona from any and all liability and damages to persons or property whatsoever connected with, incident to, or growing out of Sanctionee's show.

6) **Compliance with Rules and Regulations:** Sanctionee shall comply with all rules and regulations of SAILA as stated in the official SAILA rules which are published on the SAILA website at [www.sailashows.com](http://www.sailashows.com).

7) **Right to Cancel:** SAILA reserves the right to terminate contract granted by this Agreement for specific violation of the SAILA's rules and regulations as stated in the SAILA Rules and Regulations that are published on the official SAILA website. In the event the SAILA exercises the right retained hereunder, it shall refund, or, as may be the case, release Sanctionee from liability for payment in the amount of the sanctioning fee. Should Sanctionee exercise said right to terminate the contract, the Sanctionee agrees to forego any and all claims for damages against Sanctionor, and further agrees to waiver any and all rights which might arise by reason of the terms of this contract, and Sanctionee shall have no recourse of any kind against Sanctionor.

8) **Separation of Parties:** It is expressly understood that the SAILA being the Sanctionor grants to the Sanctionee as an independent contractor, and the ASSOCIATION shall exercise no supervision or control over the employees of the Sanctionee, or others in the service of the Sanctionee: and the Sanctionor shall provide no special services other than those specifically mentioned herein or agreed to in writing by both parties and attached to this agreement. Nothing contained in this contract shall be deemed or construed to create a partnership or joint venture between the Sanctionor and Sanctionee, or cause the Sanctionor to be liable in any way for the debts or obligations of the Sanctionee.

9) **Rules and Regulations in Regard to Show Approval:** Sanctionee hereby agrees to comply with the following SAILA Rules and Regulations in regard to show approval.

- a) Sanctionee agrees to sign and return this Agreement at least 90 days prior to Sanctionee's said show or contest. Published date of Sanctionee's show will be submitted to SAILA a minimum of 90 days prior to the event so that the show can be included in the Official SAILA Show Calendar. Sanctionee understands that shows will not be approved if dates are selected that coincide with a previously approved show.
- b) This contract shall become null and void if not properly executed and returned to a SAILA board member or representative within 90 days before the start of your show.
- c) Sanctionee understands that Sanctionor will not publish Sanctionee's show as one of the official SAILA Sanctioned

Shows until License Agreement has been signed and returned to Sanctionor. This may result in Sanctionee's show not being listed in some official SAILA publications.

- d) Sanctionee agrees to pay a cancellation fee of \$50.00 per ring for any show cancelled within 90 days of show date.
- e) Sanctionee agrees to have facilities adequate to house and show respective species of livestock being exhibited. Sanctionee agrees to provide facilities that are able to provide a form of weighing all Feeder and Market based livestock.
- f) Sanctionee agrees to open the show to all members who are in good standing with The Southern Arizona International Livestock Association. Sanctionee agrees to open the show to the world with no restrictions to residency or limit to the total number of entries entered. A confidential ineligible participants list will be provided to sanctionee if applicable.
- g) Sanctionee agrees a complete show includes a breeding division, a market division and a showmanship division. Sanctionee agrees if offering multiple rings it will include a complete show for each ring. Sanctionee agrees to adhere to the SAILA rule that an animal may not show in both breeding and market divisions in the same show.
  - 1. Sanctionee agrees to offer breeding categories for each respective specie shown at the show based on the breed and age of the breeding animal.
  - 2. Sanctionee agrees to offer market categories for each respective specie shown at the show. Sanctionee agrees to offer market categories that follow the official SAILA rules for weight breaks for the following species: Sheep – Feeders are 99 lbs and lighter, Markets are 100 lbs and up; Beef - Steer Calves are 650 lbs and lighter, Feeders are 651 – 999 lbs and Market are 1000 lbs and up; Goats – Feeders are 69 lbs and lighter, Market are 70 lbs and up; and Swine – Feeders are 199 lbs and lighter, Market are 200 lbs and up.
  - 3. Sanctionee agrees to offer showmanship classes for each species with two age divisions. The showmanship age divisions will be; junior division ages 8 to 13 years old and a senior division ages 14 to 21 years old. Sanctionee agrees to adhere to SAILA rules for age and birthdate information.
- h) Sanctionee agrees to allow SAILA to put up banners at their show completely at SAILA's expense should they choose to do so.
- i) Sanctionee agrees to charge entry fees in compliance with all other SAILA shows unless otherwise agreed to in writing by both parties and attached to this agreement.
- j) Sanctionee agrees to allow Sanctionor to set a booth at Sanctionee's show without charge to Sanctionor. This booth shall be set up at the expense of Sanctionor and shall be used to promote SAILA, its sanctioned shows and merchandise.
- k) ALL show results become the property of SAILA and may not be reproduced without written permission.
- l) If Sanctionee does not report the results to Sanctionor within FOURTEEN (14) days after said show, requests for approval of any subsequent show may be denied. Failure to mail the completed results to the Sanctionor within the prescribed time (14 days) may result in the results of this year's show or contest not being utilized in the year end SAILA point standings.
- m) Sanctionor will not be responsible for incorrect results submitted by any Sanctionee.
- n) Sanctionee agrees to give information on the breed identity of animals whenever breeds are included in competition.
- o) Sanctionee will not hold Sanctionor responsible for the formation or enforcement of Sanctionee's individual show rules. These are the sole responsibility of Sanctionee.
- p) Sanctionee agrees not to allow sanctioning by any other organization or club calf association other than SAILA without the express written permission of SAILA. Sanctionee entering into other sanctioning contracts without express written consent risk having their points excluded in the Association's point tabulation for the current year.
- q) Sanctionee agrees to pay all charges and fees within 30 days of the completion of the show.
- r) Sanctionee agrees to pay all costs related to the show: such as Judges, transportation of judges, facility rental, facility preparation, facility clean up, awards, administrative expenses, supplies, PA systems, pens / animal housing, and advertising.
- s) Sanctionee agrees to provide the names of prospective judges for approval by SAILA at least 30 days prior to the show.
- t) Sanctionee understands and agrees to the revocation of all points, and future sanctioning, if Sanctionee has broken any of the rules of this contract.
- u) Sanctionee agrees to post in all show rings livestock liability signs that will be provided by SAILA. The posted 2'X3' livestock liability signs will read as follows – "WARNING: SAILA AND OR ANY LIVESTOCK OWNER IS NOT LIABLE

FOR AN INJURY TO, OR THE DEATH OF, ANY PARTICIPANT OR SPECTATOR RESULTING FROM THE INHERENT RISKS OF BEING AROUND LIVESTOCK". The signs will be supplied by SAILA with a signed copy of this agreement and the current SAILA rules.
